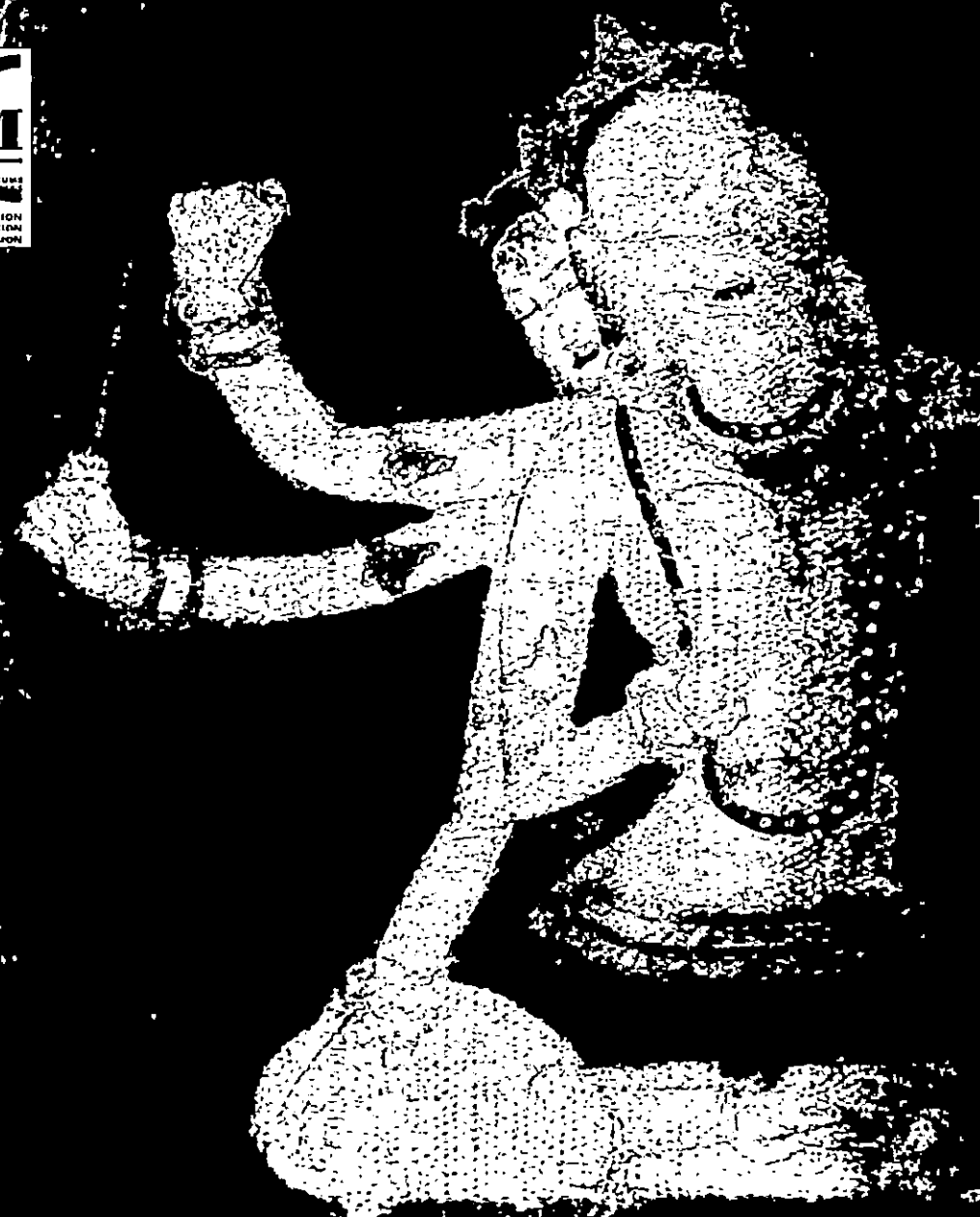

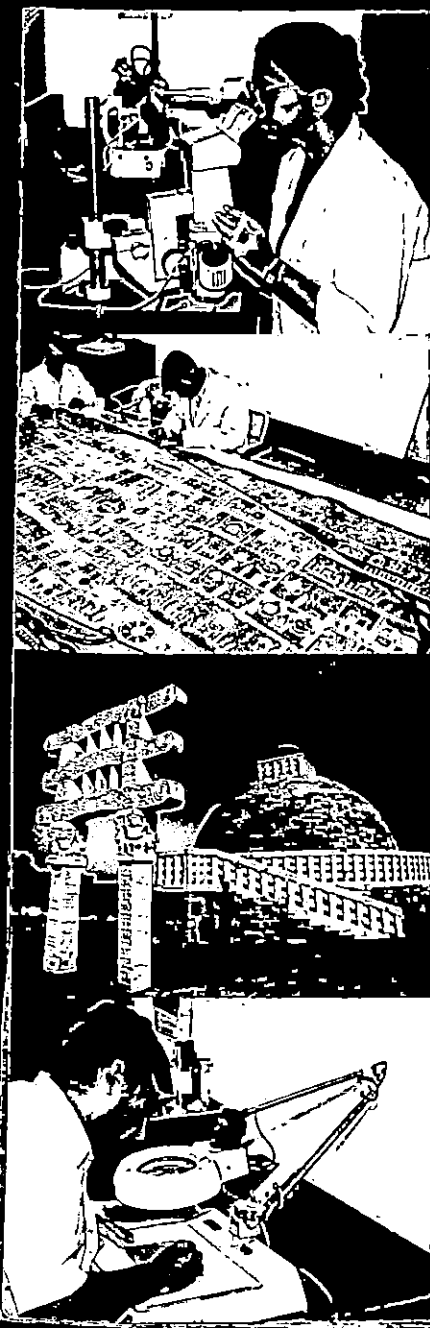

THE VENUE

I look forward to an active participation in the conference in September 2008 in New Delhi.

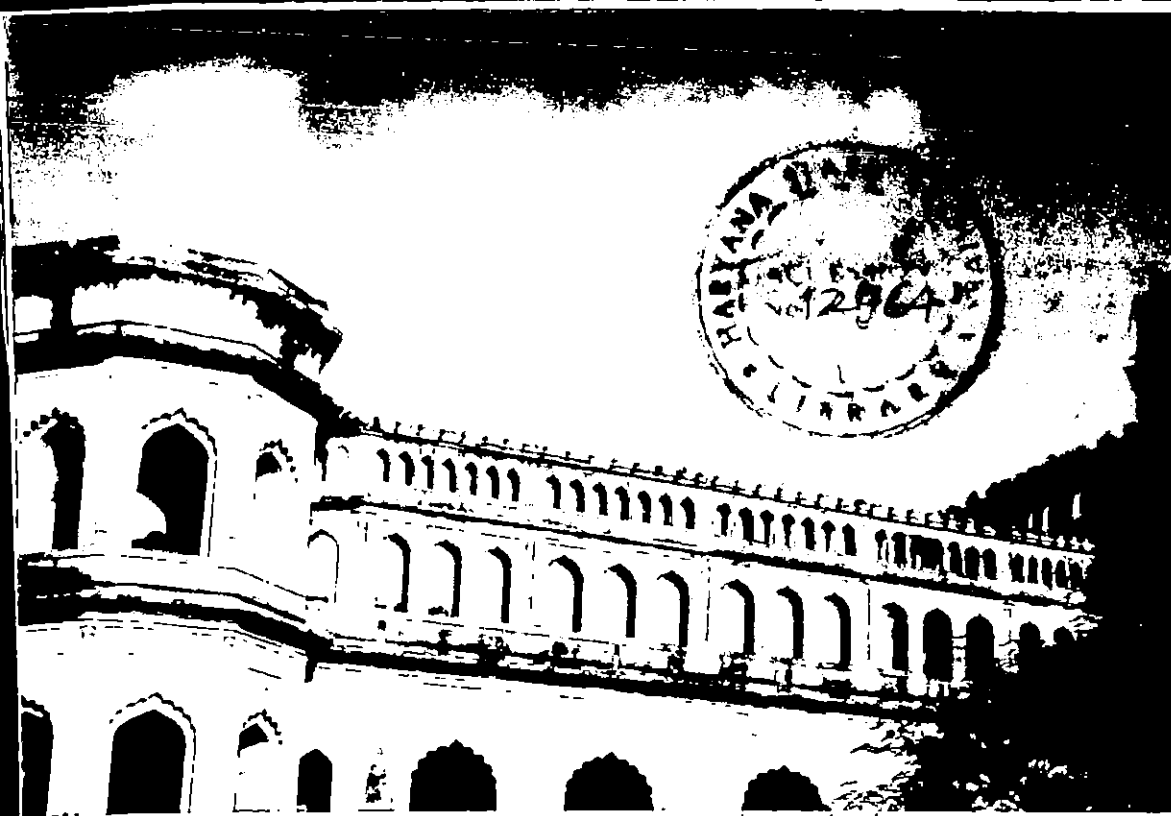

अभिलेखों में छिपे हुए तथ्यों के आधार पर ही राज्य के प्रशासनिक, राजनैतिक, आर्थिक, सामाजिक एवं सांस्कृतिक रूप का वैज्ञानिक ढंग से विश्लेषण किया जा सकता है । जहां एक ओर सरकार की योजनाओं को बनाने व कार्यरूप देने के लिए अभिलेखों का महत्वपूर्ण योगदान रहता है वहीं बीते हुए काल का इतिहास लिखने के लिए अभिलेखों का ही सहारा रहता है,

लिखे हुए इतिहास की सत्यता परखने के लिए भी केवल अभिलेख ही एक मान्य स्रोत है ।

अभिलेखों की सरकारी क्षेत्र में महत्ता होने के अतिरिक्त निजी क्षेत्र में भी इनका बहुत महत्व है । कोई भी व्यवसाय कितना ही बड़ा या छोटा क्यों न हो, उसके लिए अभिलेखों का महत्व कम नहीं होता । बैंक, उद्योग व अन्य संस्थाओं जैसी बड़ी इकाईयों से लेकर छोटे से छोटे किरयाना व पंसारी की दुकान तक के लिए उनके व्यवसाय से सम्बन्धित अभिलेखों का महत्व होता है ।

रोजमर्रा के कार्यों को निपटाने के लिए प्रयोग में आने वाले अभिलेखों के अतिरिक्त कुछ एक ऐसे भी पत्र होते हैं जिनका परिवारिक सम्पत्ति से सम्बन्ध होता है, जिन्हें आम जनता बहुत सम्भाल कर रखती है ।

इन अभिलेखों के अतिरिक्त, पोथियों, बहियों, पुस्तकों व ग्रन्थों के रूप में भी परिवारों में अभिलेख होते हैं जिनका व्यक्ति विशेष के लिए बहुत महत्व होता है व वह इन अभिलेखों के मोह को छोड़ नहीं सकता । वह उनको हर प्रकार से सुरक्षित रखने का यथा सम्भव प्रयास करता है ।

मैं यहां पर यह भी बता देना चाहती हूं कि संसार में अभिलेखागार का लाभ सरकार के साथ-साथ निजी व्यक्ति भी उठाते हैं । सभी बड़े-बड़े व्यक्तियों ने अपने तथा अपने पूर्वजों के पुराने ऐतिहासिक पत्रों को देश व राज्य के आरकाइव्स में जमा करवा दिए हैं । इसलिए हमें भी अपनी सांस्कृतिक धरोहर को चिरस्थायी बनाये रखने के लिए अपने राज्य अभिलेखागार में जमा करवाना चाहिए ।

मैं आपको यह भी बताना चाहूंगी कि अभिलेखागार विभाग में अभिलेखों को लैमिनेशन विधि द्वारा संरक्षित करके इन्हें 500 वर्ष तक सुरक्षित रखा जाता है । इस प्रणाली द्वारा मुरम्मत करना काफी मंहगा पड़ता है तथा इसके लिए सामग्री भी विदेशों से मंगवानी पड़ती है जिसके लिए विदेशी मुद्रा की भी आवश्यकता पड़ती है । अतः यह सम्भव नहीं है कि सभी अभिलेखों की इस प्रणाली द्वारा मुरम्मत की जा सके परन्तु अन्य वैज्ञानिक ढंगों तथा साज सम्भाल द्वारा अभिलेखों को चिरकाल के लिए सम्भाल कर रखा जाता है ।

अन्त में मैं हरियाणा वासियों से अपील करूंगी कि वह अपने-अपने परिवार के महत्वपूर्ण ऐतिहासिक, राजनैतिक, आर्थिक, सामाजिक व धार्मिक अभिलेखों को हरियाणा राज्य अभिलेखागार में जमा करवाएं ताकि इस राष्ट्रीय सम्पत्ति को बिखरने, नष्ट होने, समाप्त होने और उपेक्षित होने से बचाया जा सके ।




