



Is no relation of the Honble Ch Lal Chand , but is his badiness partner and lives with him and works with him on terms of the skaw closest intimacy. Does not leave the District ordinarily. Is "Policy "Editor of the Jat Gazette , a fortnightly newspaper owned really by him but nominally by a committe of Arya Jats with which is also connected the Hariana Press . Enjoys a large practice amon/; Jats especially. Was very active in War Work generally and especially recruiting and got, as reward ,5 squares of land and the title of Rai Sahib.

2. Is essentially a Jat Pleader though there are of course others. e,g, Ch Nawal Singh. Has the general redutation of being always ready to take on "sandy " cases or ones in which desperate characters characters flike Tek Bam of Khidiwal, the man recently arrested by me under the Defence Of India Rules are involved. His demeanour if in a recent case under Sec 302 I.P.C. (Crown V Changi) was recently the subject of adverse comment by the Sessions Judge, who who was remarked most strongly on the behaviour in the same case of Tek Ram. A man of considerable ability.

R.S. Chotu Ram is on the Management of of the Jat High School in which he takes the very greatest interest. He is said to have given to it the first years revenue of his recent grant of 5 squares of Colony land.

Possessed very great power in the District, probably much more than the better known Honble Lal Chand. He is said to run the District with the help of an informal committee of strong Aryas, including some officials, spread over the whole area. The Honble Lal Chand was recently elected Vice; Chairman of the District Board and Chotu Ram made this the text for a letter to the Tribune apropos of the recent failure of the Lahore Municipality to elect a non; official president in which he talked sarcastically of "Rural dependence" (meaning independence ") in Rohtak. The War and the large numbers of Committees that were formed in connection with it gave great opportivities for the acquisition of power to the Jat community, who were very quick to use them.


