Is no relation of the Honble Ch Lal Chand, but is his business partner and lives with him and works with him on terms of the ~~ex~~ closest intimacy. Does not leave the District ordinarily. Is "Policy" Editor of the Jat Gazette, a fortnightly newspaper owned really by him but nominally by a committee of Arya Jats with which is also connected the Hariana Press. Enjoys a large practice among Jats especially. Was very active in War Work generally and especially recruiting and got, as reward, 5 squares of land and the title of Rai Sahib.

2. Is essentially a Jat Pleader though there are of course others. e.g. Ch Nawal Singh. Has the general reputation of being always ready to take on "sandy" cases or ones in which desperate ~~characters~~ characters, like Tek Ram of Khidiwal, the man recently arrested by me under the Defence Of India Rules are involved. His demeanour in a recent case under Sec 302 I.P.C. (Crown V Changi) was recently the subject of adverse comment by the Sessions Judge, who also remarked most strongly on the behaviour in the same case of Tek Ram. A man of considerable ability.

3. Was the President of the Meeting held at Rohtak on the 11th April in which opposition to Govt in connection with the Rowlatt Act was advocated generally and the sale of proscribed literature urged specially. At the close of the Meeting read Gandhi's most recent message. His is the first name on the Executive Committee of the Joint Hindu and Mohaddan Committee which was formed at the meeting of the 11th.

Admits openly that he is an Arya, and is actually one of the very most advanced. He is in the closest touch with all the most active Arya personalities and institutions, e.g.

2. Munshi Ram. (Mahatma Shrada Nand) of Delhi.

3. Nathu Ram " Master " of Rohtak -a man who, having been once regarded with the greatest suspicion by the District Authorities, regained favour during the War as a recruiting orator. He is also a well;known Arya preacher. He is said to have actually lived ~~xxxx~~ lately with Chotu Ram, though he seems to be at present at the Jat High School. He has travelled widely over India.

4. Munshi Ram. Jat, of Bahadurghar, Rohtak District, A War recruiting orator and Arya Preacher.

R.S. Chotu Ram is on the Management of of the Jat High School in which he takes the very greatest interest. He is said to have given to it the first years revenue of his recent grant of 5 squares of Colony land.

Possessing very great power in the District, probably much more than the better known Honble Lal Chand. He is said to run the District with the help of an informal committee of strong Aryas, including some officials, spread over the whole area. The Honble Lal Chand was recently elected Vice;Chairman of the District Board and Chotu Ram made this the text for a letter to the Tribune (apropos of the recent failure of the Lahore Municipality to elect a non;official president in which he talked sarcastically of " Rural dependence " (meaning " independence ") in Rohtak. The War and the large numbers of Committees that were formed in connection with it gave great opportunities for the acquisition of power to the Jat community, who were very quick to use them.

4 Since the above portion of this note was written, R.S. Chotu Ram has supplied me, by way of vindicating his character, with the account of his activities in the Rohtak District over a considerable period of years. dated 2/5/19. (Exhibit 16)
It is interesting reading.
