Consequently, Infant Jesus School, Church Compound, Nandbagh Colony, Tigaria Badshah Road, Indore, Madhya Pradesh-452006, which is for Senior Secondary School Examination, is declared as a minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner institution shall not deny admission of eligible candidate of the Christian minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution and updated affiliation / recognition order issued by CBSE to the unaided petitioner institution:.

After compliance of the above order, a minority status certificate be issued accordingly.
