Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

It also transpires from the petition that in this Un-aided School during the academic year 2019-20 total 945 students were studying and out of them 211 students were from Christian Minority Community, during the academic year 2020-21 total 905 students were studying and out of them 183 students were from the Christian Minority Community and during the academic year 2021-22 total 877 students were studying and out of them 170 students belongs to the Christian Minority Community.

On perusal of the petition, it is found that this school is upto Higher Secondary level and petitioner has filed recognition certificate which is issued by Chief Educational Officer instead of Central / State Examination Board and its validity has also expired on 31.05.2022.

Learned counsel for the petitioner prayed for time to file updated recognition certificate issued by Central State Examination Board. Time prayed for is allowed.

Office is directed to tag the file no. 774 of 2019 with this case.
