The said petition is still pending. The has petitioner waited sufficiently for period of 90 days, before filing this petition.

The petitioner has already filed the proof of delivery of the registered AD to the respondent.

As per Uttar Pradesh Government notification No. 717/52-3-202-writ (30)/14 dated 05.05.2022 at present the State Competent Authority for grant of NOC to the Middle Level Educational Institute in the State of Uttar Pradesh is, Additional Chief Secretary, Department of Secondary Education, Government of Uttar Pradesh. Therefore, office is directed to implead the same authority as Respondent No. 2.

It also transpires from the petition that in this Un-aided school (middle level) during the academic year 2020-21 total 246 students were studying and out of them 85 Students from the Christian Minority Community, during the academic year 2021-22 total 230 students were studying and out of them 80 were from Christian Minority Community and during the academic year 2022-23 total 280 students were studying and out of them 90 students belongs to the Christian Minority Community. In this case office has reported that education level of the petitioner Institute is upto Middle (upto 8<sup>th</sup> class) but as per the recognition certificate issued by District Education Officer, Ghaziabad, dated 24.05.2005, its only for Primary Level classes and as per the condition no. 1 of the said recognition certificate petitioner Institute cannot run classes for standard 6<sup>th</sup> to 8<sup>th</sup> but as per petition filed by the petitioner, school is already running upto class 8<sup>th</sup>. It means petitioner Institute is also running classes of 6<sup>th</sup> to 8<sup>th</sup> Standard without permission, which is illegal.

Learned counsel for the petitioner submitted that the petitioner institute has not filed any recognition certificate issued by Central / State Examination Board but all other formalities are complete. So please issue notice to the respondent.

Learned counsel for the petitioner prayed for time to file updated recognition certificate issued by the Central / State Examination Board.

We heard learned counsel for the petitioner and in our considered opinion the notice can be issued to the State Competent Authority of the Tamil Nadu.
