Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

It also transpires from the petition that in this Un-aided school (Higher Secondary level) during the academic year 2020-21 total 1301 students were studying and out of them 1249 were from the Muslim Minority Community, during the academic year 2022-23 total 1254 students were studying and out of them 1200 were from the Muslim Minority Community.

In this case office has reported that petitioner has filed list of present Governing Body Members but the same has not certified by the registrar of the societies and beneficiary clause is also not available in the MoA.

Learned counsel for the petitioner argued in the matter and submitted that the beneficiary clause is available as mentioned at point No. 4a and 4b in the MoA.

Learned counsel for the petitioner prayed for time to clarify the above said discrepancies.
