An application has been received by hand on 16.09.2022 from Guru Nanak Public School, Village – Jagaatkhana, Himachal Pradesh for grant of minority status certificate. It be registered.

It transpires from the petition that on 23.02.2022 the petitioner has applied for grant of No Objection Certificate to the State Competent Authority i.e. Director, Directorate of Higher Education, Himachal Pradesh, Shimla - 1.

Thereafter, State Competent Authority vide order No. EDN-H (21) A (1) P.S.-28/2022 – (NOC)-Minority dated 10.08.2022 grant No Objection Certificate to the petitioner Institute.

Petitioner institute has submitted Resolution passed by the Governing Body of the Society to obtain Minority Status Certificate from this Commission, which is in Punjabi Language and petitioner has not filed translation in Hindi or English.

It also transpires from the petition that in this Un-aided School during the academic year 2020-21 total 935 students were studying and out of them 593 students were from Sikh Minority Community, during the academic year 2021-22 total 900 students were studying and out of them 570 students were from the Sikh Minority Community and during the academic year 2022-23 total 982 students are studying and out of them 601 students belongs to the Sikh Minority Community. Petitioner has already filed envelope with postage charges for sending notice to the State Competent Authority.

In this case office has reported that Beneficiary clause for the concerned Minority Community is not available in the MoA filed by the petitioner.

It is also transpire from the petition that against the column no. 5 (*whether the applicant institution has ever applied to the NCMEI for grant of MSC*) of the MSC application petitioner furnished information as 'No' whereas earlier also petitioner had applied and case was registered as case No. 21 of 2022.

Office is directed to tag the File No. 21 of 2022 with this case.

Mr. Hinder Singh prayed for time to comply with the above order. Time prayed for is allowed.
