An application has been received by hand on 21.10.2022, from Cherural HSS Kurumbathur, Cherural HSS Kurumbathur, Malappuram District, Kerala – 676301, as an Individual Management Case, for grant of minority status certificate. It be registered.

Perused the office report and it transpires from record that the petitioner has not applied for grant of No Objection Certificate before the State Competent Authority.

The Hon'ble Supreme Court in Civil Appeal No. 3945 of 2018 in case of Sisters of St. Joseph of Cluny vs. The State of West Bengal and Ors. vide order dated 18.04.2018, has held that any person who desires to establish a minority educational institution after the amendment Act of 2006 came into force, must apply only to the competent authority for grant of No Objection Certificate for the said purpose.

All applications for the establishment of a minority educational institution after the amendment Act of 2006 must go to the competent authority set up under the statute

It also transpires from the records, that the petitioner has also applied before the State Competent Authority for grant of Minority Status Certificate and that application is still pending.

As per law and settled procedure, petitioner cannot apply before this Commission unless and until the Minority Status Certificate application is disposed by the State Competent Authority. Hence this application is not maintainable at this stage.

In this case, office has reported that the petitioner has not filed General Boady Resolution and Recognition certificate with this petition.

Learned counsel for the petitioner prayed for time to file certain relevant documents. Time prayed for is allowed.

It transpires from the petition that on 07.10.2021, the petitioner has applied for grant of No Objection Certificate to the then State Competent Authority i.e. Additional Chief Secretary, Department of School Education, Government of U.P., Bahu Khandi, Secretariat, Lucknow, U.P. – 226001, which was received by the respondent on 20.10.2021, The said petition is still pending. The petitioner has waited sufficiently for a period of 90 days, before filing this petition.

The petitioner has already filed the proof of delivery of the registered AD to the respondent.

As per Uttar Pradesh Government notification No. 717/52-3-202-writ (30)/14 dated 05.05.2022 at present the State Competent Authority for grant of NOC to the Madarsah in the State of Uttar Pradesh is, Additioal Chief Secretary, Minority Welfare and Waqf Department, Government of Uttar Pradesh. Therefore, office is directed to implead the same authority as Respondent No. 2.

Petitioner has filed Resolution passed by the Governing Body to obtain Minority Status Certificate from this Commission.

It also transpires from the petition that in this Un-aided School during the academic year 2020-21 total 413 students were studying and out of them 327 students were from the Muslim Minority Community, during the academic year 2021-22 total 397 students were studying and out of them 315 students were from the Muslim Minority Community and during the academic year 2022-23 total 395 students are studying and out of them 325 students belongs to the Muslim Minority Community.

Office has reported that petitioner has filed 02 envelopes with postage of Rs. 50 and Rs. 25.

Learned counsel for the petitioner is directed to file 01 more additional envelope with postal charges for sending notice to the respondents.

After compliance of the above order by the petitioner, office is directed to issue notice by registered Ad/e-mail to the respondents.
