The FCRA registration (Reg No. 052950021) owned by the college was taken at the initial stage of development of the college (1981), which started with the objective of imparting quality education to the society to an otherwise under privileged, backward area of Malappuram District. The institution has informed that they have not received any fund in the FCRA account after 2015 and the account has been subjected to annual audits by competent authority and the reports have been submitted to MHA. They have also informed that the registration was cancelled on 18.11.2019 as they could not submit the annual returns of the year 2017-18 due to technical reasons.

The District Collector in his report under reference has informed that Mar Thoma College, respondent no. 1 was established as a Minority institution in 1981 under Marthoma Syrian Church. The college has got minority status from NCMEI in 2012. He has informed that matters relating to foreign funding may be got enquired through the concerned authorities.

Despite giving registered notices and also e-mails again and again to the Complainant, none appeared on behalf of the complainant and Marthoma Warriors has deleted his e-mail account.

Since nobody has appeared to make any submission. The Commission has waited sufficiently. The Commission has been forced to dismiss the petition.

Hence, the petition is dismissed in default.
