As per law and settled procedure, petitioner cannot apply before this Commission unless and until the Minority Status Certificate application is disposed by the State Competent Authority. Hence this application is not maintainable at this stage.

In this case office has reported that the petitioner Institutions is an individual management school and was established by Mr. S. Sankarasubbu who belongs to the Hindu community and there is no documentary evidence to substantiate as to how the school has been taken over by the Present Governing Body.

It also transpires from the record that most of documents filed by the petitioner along-with the MSC application are in Tamil language and Hindi/ English translation has not been furnished by the petitioner.

Office is directed to issue show cause notice by registered AD/ e-mail to the petitioner as to why this petition may not be dismissed at this stage.
