The Hon'ble Supreme Court in Civil Appeal No. 3945 of 2018 in case of Sisters of St. Joseph of Cluny vs. The State of West Bengal and Ors. vide order dated 18.04.2018, has held that any person who desires to establish a minority educational institution after the amendment Act of 2006 came into force, must apply only to the competent authority for grant of No Objection Certificate for the said purpose.

All applications for the establishment of a minority educational institution after the amendment Act of 2006 must go to the competent authority set up under the statute.

It also transpires from the records, that the petitioner has also applied before the State Competent Authority for grant of Minority Status Certificate and that application is still pending.

As per law and settled procedure, petitioner cannot apply before this Commission unless and until the Minority Status Certificate application is disposed by the State Competent Authority. Hence this application is not maintainable at this stage.

In this case, office has reported that the petitioner has filed conditional recognition certificate which is also expired and petitioner has not filed General Body Resolution to obtain Minority Status Certificate from this Commission and envelope with postage charges for sending notice to the State Competent Authority.

It also transpire from the petition that in this Un-aided School total 333 students are studying and out of them 292 students are from the Muslim Minority Community and petitioner has left blank many colums of the MSC application.
