The petitioner has already filed the proof of delivery of the registered AD to the respondent.

Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

It also transpires from the petition that in this Un-aided school (Secondary level) during the academic year 2020-21 total 789 students were studying and out of them 142 Students from the Christian Minority Community, during the academic year 2021-22 total 461 students were studying and out of them 78 were from the Christian Minority Community and during the academic year 2022-23 total 634 students were studying and out of them 158 students belongs to the Christian Minority Community.

In this petition Amended Memorandum of Association of the Society is prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

In this case office has reported that recognition filed by the petitioner does not indicate the classes for which the certificate has issued.

On perusal of the notification dated 19.06.2007 issued by Human Resource Development Department of Bihar Government, it is found that Government of Bihar has recognized this school upto Secondary Level.

Learned counsel for the petitioner prayed for time to file recognition / affiliation certificate issued by Central / State Examination Board.

In the interest of justice and on the request of the learned counsel for the petitioner, Office is directed to issue notice by registered AD and e-mail to the respondent.
