As per law and settled procedure, petitioner cannot apply before this Commission unless and until the Minority Status Certificate application is disposed by the State Competent Authority. Hence this application is not maintainable at this stage.

In this case, office has reported that the petitioner has not filed General Body Resolution to obtain MSC from this Commission, envelope with postage charges for sending notice to the State Competent Authority and Beneficiary clause for concerned Minority is also not available in the Trust Deed filed by the petitioner.

Office is directed to issue show cause notice to the petitioner by e-mail as to why this petition may not be dismissed at this stage.

In the interest of justice, list the case with other similar matters on 15.09.2022.
