“Relying on the said unrebutted evidence produced on behalf of the petitioner, we find and hold that Sri Guru Nanak Public School, Adarsh Nagar, Delhi-110033 run by Sri Guru Singh Sabha is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the sikh minority community.

Consequently, Sri Guru Nanak Public School, Adarsh Nagar, Delhi-110033 is declared as a minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner institution shall not deny admission of eligible candidate of the Sikh minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution.”

After compliance of the above order, a minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
