First of all we make it clear that petitioner has not furnished any information about the facts that petitioner has already obtained Minority Status from the State of Tamil Nadu. Petitioner has also submitted information against the column no. 5 of the MSC application that no authority has granted minority status to the petitioner institution. Petitioner also declared that particulars furnished in the application for grant of MSC are true to the best of his knowledge and belief and certainly this declaration is not correct as per the record.

It is clear from the above mentioned facts that the petitioner has not come with the clean hands before the Commission.

Petitioner has not challenged any order of the State Competent Authority, even this Commission has Appellate Powers also. Without going to pass any order on merits, we are of the considered opinion that this application for grant of MSC is not maintainable at this stage, because at this time petitioner institution has Minority Status granted by the State Competent Authority. Hence, this application is deserved to dismissed.
