Perused the office report and it transpires from record that the petitioner has not applied for grant of No Objection Certificate before the State Competent Authority.

The Hon'ble Supreme Court in Civil Appeal No. 3945 of 2018 in case of Sisters of St. Joseph of Cluny vs. The State of West Bengal and Ors. vide order dated 18.04.2018, has held that any person who desires to establish a minority educational institution after the amendment Act of 2006 came into force, must apply only to the competent authority for grant of No Objection Certificate for the said purpose.

All applications for the establishment of a minority educational institution after the amendment Act of 2006 must go to the competent authority set up under the statute.

It also transpires from the records, that petitioner has applied before the State Competent Authority for grant of Minority Status Certificate also and that application is still pending, petitioner has not filed envelope and postage for sending notice to the respondent and General Body Resolution to obtain MSC.

So as per the law and settle procedure, petitioner cannot apply before this Commission until unless the disposal of that application which is still pending before the State Competent Authority. So this application is not maintainable at this stage.

In this case, office has reported that the petitioner has mentioned UID no. in the MSC application but not attached complete UID issued by the NITI Ayog with the petition, General Body Resolution to obtain Minority Status Certificate from this Commission, envelope with postage charges for sending notice to the State Competent Authority and specific beneficiary clause is also not available in the MoA for the concerned Minority Community.

Office is directed to issue show cause notice to the petitioner by post and e-mail as to why this petition may not be dismissed at this stage.
