ORDER

DATED 06.10.2021

1. The petitioner Mr. Jasbir Singh, Authorized Signatory of Kalgidhar Society filed an application on dated 22.10.2020 stating that this Commission has declared Akal Academy, Gomtipul, Navadia Sultanpur, Puranpur, Pilibhit, Uttar Pradesh as a minority educational institution covered under Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 vide order dated 23.01.2009 in Case No. 829 of 2008.
2. As per the petitioner original minority status certificate was lost and the same was reported to the Police Station, Puranpur, Pilibhit, Uttar Pradesh on 08.10.2020. Sub Inspector, Police Station Puranpur, Pilibhit, Uttar Pradesh has issued a letter to that effect. Petitioner has also declared that the minority status certificate is lost and traceless. Sub Inspector, Police Station Puranpur, Pilibhit, Uttar Pradesh has also given letter dated 15.09.2021 that efforts were made to trace the MSC, but not trace till date.
3. Mr. Jaspreet Singh for the petitioner has submitted that petitioner institution even though being a minority institution is not able to avail any benefit of minority status. All concerned departments are asking the petitioner to produce the said certificate, so the petitioner is in urgent need of duplicate minority status certificate from this Commission.
4. Special Secretary of UP Govt. has sent a letter dated 20.09.2021 that they have forwarded the original notice and application to Secondary Education Department, Govt. of UP for further necessary action. The institution is affiliated from CBSE which comes under Secondary Education Department, Govt. of UP.

5. Vide order dated 23.01.2009, minority status certificate was granted to Akal Academy, Gomtipul, Navadia Sultanpur, Puranpur, Pilibhit, Uttar Pradesh run by The Kalgidhar Society by this Commission in Case No. 829 of 2008.
6. We have heard the Mr. Jaspreet Singh for the petitioner and perused the relevant documents, application for duplicate minority status certificate, affidavit of Mr. Jasbir Singh, Authorized Signatory of The Kalgidhar Society, missing certificate report and also the original letter.
7. We have no reason to disbelieve the uncontroverted affidavit of Mr. Jasbir Singh, Authorized Signatory of The Kalgidhar Society filed on behalf of the petitioner institution. We are satisfied by the Affidavit, FIR and not traceable letter issued by the Sub Inspector, Puranpur, Pilibhit, Uttar Pradesh.
8. Accordingly, in the interest of justice the duplicate minority status certificate be issued to Akal Academy, Gomtipul, Navadia Sultanpur, Puranpur, Pilibhit, Uttar Pradesh run by The Kalgidhar Society subject to the condition that the petitioner would file an affidavit undertaking mentioning that they will not misuse the duplicate minority status certificate and also submit that in the event of found the original minority status certificate they shall return it to the Commission.

Accordingly, the application filed by the petitioner is disposed of.
