In this case, office has reported that the petitioner has filed General Body Resolution to obtain MSC from this Commission, envelope with postage charges for sending notice to the State Competent Authority.

It also transpires from the petition that in this Un-aided School during the academic year 2019-20 total 7365 students were studying and out of them 158 students were from Christian Minority Community, during the academic year 2020-21 total 7836 students were studying and out of them 174 students were from the Christian Minority Community and during the academic year 2021-22 total 8307 students are studying and out of them 189 students belongs to the Christian Minority Community.

Learned counsel for the petitioner submitted that the petitioner Institute runs by the Company which is a charitable company and in support of this petitioner wants to submit some more documents.

Office is directed to issue notice to the respondent by registered AD/email.
