7. In this case office has reported that petitioner has not filed approval from the Pharmacy counsel and name of trustees are appear different in UID filed by the petitioner.
8. Learned counsel for the petitioner seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted. Accordingly, the petition is disposed of as withdrawn.
