- 5. In this petition Amendment has been made in the Memorandum of Association prior to the filing of NOC application before the State Competent Authority u/s 10 of NCMEI Act. 2004 and filing of MSC application before the Commission.
- 6. In this case, office has reported that against the column no. 6(a) petitioner has not furnished proper information related to the Muslim Minority Community Students and Teachers, Petitioner has not filed copy of original MoA with this petition and name of signatory of this MSC application is not available in UID issued by Niti Ayog.
- 7. Office is directed to issue show cause notice to the petitioner as to why this petition may not be dismissed at this stage.
- 8. In the interest of justice, list on 27.09.2023.
