4. Petitioner has filed Resolution passed by the Governing Body to obtain Minority Status Certificate from this Commission.
5. It also transpires from the petition that in this Un-aided School (Secondary Level) during the academic year 2021-22 of the 624 enrolled students 315 are from the Christian Minority Community, in academic year 2022-23 of the 545 enrolled students 275 are from the Christian Minority Community, in academic year 2023-24 of the 534 enrolled students 270 are from the Christian Minority Community.
6. After perusal of the record, we found that Sr. Julie has filed this application before this Commission for grant of Minority Status Certificate as Trustee, Association for Social Involvement Service in India and her name is available in the Trust Deed which is duly certified by the Sub-Registrar Kanjirapally.
7. The petitioner Institution has applied for grant of Minority Status Certificate on the ground that the same has been established and is being administered by Association for Social Involvement Service in India, constituted by the members of the Christian Community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Sr. Julie.

- 8 We have perused the Trust Deed of the Petitioner Institute which was registered before the Sub - Registrar of the Trusts on dated 14.11.2018 which is well before the filing of No Objection Certificate (NOC) application u/s 10 of NCMEI Act., 2004 and application for grant of Minority Status Certificate (MSC) on dated 14.08.2023. So it is clear that the amendment in the Trust Deed is before the filling of No Objection Certificate (NOC) application u/s 10 of NCMEI Act., 2004 dated 25.05.2022 and application for grant of Minority Status Certificate (MSC) on dated 14.08.2023 before the Commission.
- 9 In the fact and circumstances of the case, we are of the considered opinion that when the State of Kerala has granted No Objection Certificate to the petitioner Institute to obtain Minority Status Certificate from this Commission, there is no need to give any notice to the respondent i.e. State Competent Authority.
- 10 Office is directed to return Envelope and postage charges to the petitioner.
