It transpires from the petition that on 13.12.2022, the petitioner has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Basic Education Department, Government of Uttar Pradesh, Bapu Bhawan, 7th Floor, Lucknow, Uttar Pradesh - 226001, which was received by the respondent on 16.12.2022. The said petition is still pending. The petitioner has waited sufficiently for period of 90 days, before filing this petition.

During the academic year 2020-21 of the 198 enrolled students 20 are from the Sikh Minority Community, in 2021-22 of the 211 enrolled students 23 are from the Sikh Minority Community, in 2022-23 of the 297 enrolled students 31 are from the Sikh Minority Community.
6. In this petition Amendment in Memorandum of Association of the Society is prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.
