So it is not clear that whether this school runs by Society or Trust.
- 8. Office has also reported that petitioner has furnished list of Governing Body Members wherein Name and Designation is available but petitioner has not mentioned their religion.
- 9. Learned counsel for the petitioner has submitted that petitioner has filed certified copies of the documents alongwith petition, be return.
- 10. Learned counsel for the petitioner also seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief.
- 11. Leave and liberty is granted. The petition is disposed of as withdrawn.
