It transpires from the petition that on 02.12.2022, the petitioner has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Department of Secondary Education, Government of Uttar Pradesh, Bapu Bhawan, 7th Floor, Lucknow, Uttar Pradesh - 226001, which was received by the respondent on 07.12.2022. 3. The petitioner has already filed the proof of delivery of the registered AD to the respondent.

4. Petitioner has also filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is Un-aided School (Higher Secondary Level). During the academic year 2020-21, out of 1263 enrolled students, 18 were from the Christian Minority Community, in 2021- 22, out of 1267 enrolled students, 22 were from the Christian Minority Community and in 2022-23 out of 1341 enrolled students, 23 were from the Christian Minority Community

6. In this petition Amendment in Memorandum of Association of the Society is prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.
