2. It transpires from the petition that on 23.12.2022, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Principal Secretary, School Education Department, Government of Tamil Nadu, Rina Road, Fort St. George, Secretariat, Chennai, Tamil Nadu- 600 009, which was received by the respondent on 26.12.2022. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition.

3. The petitioner has already filed the proof of delivery of track consignment to the respondent.

4. The petitioner has filed copy of certificate dated 28.6.2021 issued by Asst. Ele. Edu. Officer, Salem District certifying that the petitioner institution is permanently recognized school.

5. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

6. It also transpires from the petition that the petitioner Institute is an aided school (Primary). During the academic year 2020-21, out of total 661 students, 52 students were from the Christian Minority Community, in the year 2021-22, out of 617 students, 51 students were from the Christian Minority Community and in the year 2022-23, out of 628 student, 54 students were from the Christian Minority Community.
