In the year 2020-21, out of total 224 students, 06 students were from the Christian Minority Community, in the year 2021-22, out of 218 students, 09 students were from the Christian Minority Community and in the year 2022-23, out of total 227 students, 07 students were from the Christian Minority Community. That there is variance between proof and pleading.

Learned Counsel for the petitioner seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted.
