It transpires from the petition that on 22.10.2022, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Secretary, Department of Minorities Welfare, Government of Andhra Pradesh, 3rd Floor, Andhra Pradesh Secretariat, Velangapudi, Amravati, Andhra Pradesh- 521 185, which was received by the respondent on 25.10.2022. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition.

3. The petitioner has already filed the proof of delivery of track consignment to the respondent.

4. The petitioner has filed copy of letter dated 11.10.2023 issued by the Registrar, Andhra Kesari University, Andhra Pradesh granting temporary affiliation to the petitioner institution for the academic year 2023-24.

6. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Education).
