2. It transpires from the petition that on 5.10.2023, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Director, Primary Education, Department of School Education & Literacy S.E & L. Department, MDI Building, Post - Dhurwa, District - Ranchi, Jharkhand- 834 004, which was received by the respondent on 11.10.2023. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed Notarized copy order dated 17.3.2012 issued by Director (Secondary Education Directorate), Human Resource Development Department, Jharkhand granting permanent permission to the petitioner institution.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Secondary).

6. During the academic year 2020-21, out of total 1602 students, 183 students were from the Christian minority community, in the year 2021-22, out of total 1506 students, 177 students were from the Christian minority community and in the year 2022-23, out of total 1536 students, 174 students are from the Christian minority community.
