As per law and settled procedure, if the minority educational institution is being run by a trust or a registered society, then majority of the trustees of the trust or members of the society, as the case may be, must be from the minority community and the trust deed/ Articles of Association or any other document duly executed in this regard must reflect the objective of subserving the interest of the minority community.

4. Heard learned counsel for the petitioner at some length. Learned counsel for the appellant has submitted that the majority founding trustees of the appellant trust were from the Muslim minority community. He has prayed for time to file certificate regarding religion of founding trustees. Time prayed for is allowed.

5. Perused the record. The aims and objects of the Trust Deed of the appellant Trust does not reflect that the Trust is run primarily for benefit of the Muslim minority community.
