An application has been received by hand on 19.2.2024 from St. Jude's Hospital College of Nursing, St. Jude's Hospital, Sipri P.O., Jhansi District, Uttar Pradesh- 284 003 for grant of minority status certificate. It be registered.

2. It transpires from the petition that on 27.5.2023, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Higher Education Department, Govt. of Uttar Pradesh, Room No. 3, Naveen Bhawan, UP Secretariat, Lucknow- 226 001, which was received by the respondent on 31.5.2023. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized copy of list dated 19.12.2023 issued by Indian Nursing Council showing the list of institution offering B.Sc (N) Programme inspected for the academic year 2023-24.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Education). During the academic year 2021-22, out of total 192 students, 139 students were from the Christian minority community and in the year 2022-23, out of total 178 students, 128 students were from the Christian minority community and in the year 2023-24, out of total 180 students, 104 students are from the Christian minority community.

6. It transpires from the petition that the amendment in the Memorandum of Association of the petitioner Society was done prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.

7. Office has reported that there is mismatch between registry number furnished and number for which delivery details has been furnished. However, it transpires from the tracking report that the last nine digits 923900656 mentioned in the postal receipt matches with the registry number. Hence, Office report may be ignored.
