The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized copy of order dated 6.7.2021 issued by CBSE granting affiliation to the petitioner institution from 1.4.2022 to 31.3.2027.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Secondary). During the academic year 2021-22, out of total 1700 students, 18 students were from the Christian minority community and in the year 2022-23, out of total 1840 students, 19 students were from the Christian minority community and in the year 2023-24, out of total 1912 students, 20 students are from the Christian minority community.

6. It transpires from the petition that the amendment in the Memorandum of Association of the petitioner Society was done prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.

7. The petitioner has submitted Certificate of Registration, MOA and Rules & Regulations of "International Needs India". However, in amended MOA, the name of the Society has been mentioned as "ACTS Groups of Institutions". It appears that there is change of name of the petitioner society.

8. Learned Counsel for the petitioner seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted.

9. The petition is disposed of as withdrawn. Office is directed to return additional sets, envelope and postage charges to the learned counsel for the petitioner. Record of Case No. 940 of 2018 be tagged with the record of this case.
