An application has been received by hand on 26.4.2024 from St. Xavier's School, Post Box No. 3, Jamnagar, Gujarat- 361 008 for grant of minority status certificate. It be registered.

2. It transpires from the petition that on 30.11.2023, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Deputy Director, Director of Schools, Government of Gujarat, Old Secretariat, Block 9/1, Gandhinagar, Gujarat- 382 010, which was received by the respondent on 2.12.2023. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition.

3. The petitioner has filed notarized copy of order dated 31.1.2022 issued by District Education Officer, Jamnagar Corporation sanctioning additional class for the school. The said order is in Gujarati language. English translation thereof duly notarized by the Notary Public has been filed.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Middle). During the academic year 2021-22, out of 1243 students, 42 students were from the Christian minority community, in the year 2022-23, out of 1313 students, 42 students were from the Christian minority community and in the year 2023-24, out of 1270 students, 46 students were from the Christian minority community.

6. It transpires that the amendment in the Memorandum of Association of the petitioner Society was done prior to filing application u/s 10 of NCMEI Act, 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

7. Office has reported that the institution is said to be run by Society in MSC application but as per Unique ID, it is trust. Learned counsel for the petitioner has submitted that the petitioner institution is run by the Society is registered under Bombay Public Trust Act, 1950 and the Registration Number of the Society mentioned in the Unique ID matches with the Certificate of Registration of Society.

8. There is variance between proof and pleadings as it has been mentioned against Col. No. 4 of the petition that the petitioner has applied to the Director, Primary Education, Dr. Jivraj Mehta Bhavan, 2nd Floor, 12/1, Gandhinagar, Gujarat- 382 010, for grant of NOC whereas the application was endorsed to Deputy Director, Director of Schools, Government of Gujarat, Old Secretariat, Block 9/1, Gandhinagar, Gujarat- 382 010.
