6. It transpires that the Trust Deed of the petitioner trust registered on 7.2.2019 prior to filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

7. Office has reported that the Registration Certificate of Society/ Trust is not furnished. In MSC application institution is mentioned to be run by Trust but in Unique ID it is mentioned as "Registered Society". Learned counsel for the petitioner has submitted that the petitioner institution is run by a Trust, which is duly registered and not by a Society and no separate certificate is issued. Hence, office report is ignored.
