6. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Secondary). During the academic year 2022-23, out of 298 students, 178 students were from the Muslim minority community, in the year 2023-24, out of 378 students, 255 students were from the Muslim minority community and in the year 2024-25, out of 424 students, 298 students were from the Muslim minority community.

7. It transpires from the petition that the Trust Deed of the petitioner trust was registered prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

8. Office has reported that the beneficiary clause does not clearly indicate the aim and object of the trust. Clause No. 3.03 of the Trust Deed dated 24.3.1993 clearly states the beneficiary clause. Hence, the office report is ignored.

8. It transpires from the petition that the trust deed of the petitioner trust was registered prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

9. Office has reported that the beneficiary clause does not indicate clearly the object of the school as establishing MEI but facilitating scholarship and fellowship for Muslim minority students. It transpires from the record that the Resolution filed by the petitioner does not bear the names of the signatories.

10. Mohd. Sharim seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted.
