3. The petitioner has filed notarized copy of letter dated 1.2.2024 issued by Deputy Director Office, Department of Public Education, Karnataka granting recognition to the petitioner institution for the academic year 2023-24. The said order is in Kannada language. English translation thereof duly notarized by the notary public has been filed.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Secondary). During the academic year 2021-22, out of 399 students, 07 students were from the Christian minority community, in the year 2022-23, out of 365 students, 06 students were from the Christian minority community and in the year 2023-24, out of 403 students, 13 students were from the Christian minority community.

6. It transpires from the petition that the amendment in the Memorandum of Association of the petitioner society was done prior to the filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

7. Office has reported that NOC application addressed to competent authority of Karnataka. However, postal receipt of Lucknow is enclosed. Learned counsel for the petitioner is directed not to mislead the Commission and be careful in future before filing application for grant of minority status certificate before the Commission.

8. Leaned counsel for the petitioner has submitted that inadvertently, this error has occurred. He seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief.
