By the physical inspection report dated 08.02.2024, the members of the Physical Inspection Committee during the academic year 2021-22, out of total 195 students, 65 students were from the Muslim minority community, 19 students were from the Christian minority community and 111 students were Hindus. It is also stated therein that during the academic year 2021-22, out of total 27 teachers, out of the total 27 teachers, 5 teachers were from the Muslim Minority community, 4 teachers were from the Christian minority community and 18 teachers were Hindus.
2. On the contrary, petitioner has mentioned against the Col. No. 6 of the petition for grant of MSC that during the academic year 2021-22, out of total 572 students, 156 students were from the Muslim minority community, 107 students were from the Christian minority community, 1 student was from the Jain minority community, 1 student was from the Buddhist minority community and 307 students were Hindus. It is also stated against the col. No. 6 of the petition for grant of MSC, out of total 21 teachers, 5 teachers were from the Muslim minority community, 4 teachers were from the Christian minority community and 14 teachers were Hindus. Thus there is an apparent inconsistency between the factual position stated in the petition for grant of MSC and Physical Inspection Report.
