3. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

4. It also transpires from the petition that the petitioner Institute is a private unaided institution (Higher Secondary).

5. It transpires from the petition that the amendment in the Memorandum of Association of the petitioner society was done prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.

6. The petitioner has not supplied complete information against Col. No. 6 (a) of the application. The declaration part of the petition has also been left blank.

7. It is stated against Col. No. 4 (a) of the application that the petitioner institution has applied for No Objection Certificate before the State competent authority on 22.6.2023 but the petitioner has not annexed a copy of the said letter.

8. As per Notice dated 10.5. 2024 issued by Commission in F. No. 3-2/2020-NCMEI mentioning therein that the petitioner institution should apply for MSC within nine months from the date of submitting NOC application before the State Competent Authority.

9. Hence, the petition is not maintainable. Accordingly the petition is dismissed in default. Petitioner be informed accordingly.
