After compliance of the above order, a minority status certificate be issued accordingly.

2. It transpires from the petition that on 1.2.2024, the petitioner has applied for grant of No Objection Certificate to the State Competent Authority i.e. Principal, Technical Education, Govt. of Uttar Pradesh, Room No. 63, Naveen Bhawan, U.P. Secretariat, Lucknow, Uttar Pradesh- 226 001, which was received by the respondent on 5.2.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition.

3. The petitioner has already filed the proof of delivery of track consignment to the respondent.

4. The petitioner has filed notarized copy of letter dated 4.8.2023 issued by Pharmacy Council of India granting approval for 2023-24 to conduct of 1st year B. Pharma course with 60 seats and notarized copy of letter dated 7.6.2023 issued by Pharmacy council of India grating approval for D. Pharma for the academic year 2023-24 with approved intake of 60 students.

5. It transpires from the petition that the petitioner Institute is an unaided institution (Higher Education). During the academic year 2021-22, out of total 57 students, 48 students were from the Muslim minority community in the year 2022-23, out of total 64 students, 58 students were from the Muslim minority community and in the year 2023-24, out of total 28 student, 22 students were from the Muslim minority community.
