A bare reading of the physical inspection report makes it clear that during the academic year 2021, out of total 556 students, 185 students belong to Muslim minority community, 32 students belong to Christian minority community, 01 student belongs to Sikh minority community and 338 students are from the Hindu community. In the year 2022, out of total 621 students, 207 students belong to Muslim minority community, 35 students belong to Christian minority community, 01 student belongs to Sikh minority community and 378 students are from the Hindu community.

As per the information supplied by the petitioner with regard to students strength during the academic year 2020-21, out of total 745 students, 250 students belong to Muslim minority community, 75 students belong to Christian minority community, 20 students belong to Sikh minority community and 400 students are from the Hindu community. In the academic year 2021-22, out of total 1045 students, 525 students belong to Muslim minority community, 51 students belong to Christian minority community, 12 students belong to Sikh minority community and 457 students are from the Hindu community.

In the year 2022-23, out of total 373 students, 30 students belong to Muslim minority community, 12 students belong to Christian minority community, 03 student belongs to Sikh minority community, 02 students belong to Jain minority community and 326 students are from the Hindu community.

As per the information supplied by the petitioner with regard to students strength during the academic year 2021-22, out of total 345 students, 15 students belong to Muslim minority community, 04 students belong to Christian minority community, 01 student belong to Sikh minority community and 325 students are from the Hindu community. In the academic year 2022-23, out of total 548 students, 24 students belong to Muslim minority community, 06 students belong to Christian minority community, 01 student belong to Sikh minority community and 517 students are from the Hindu community.

If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of msc will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.
