A bare reading of the physical inspection report makes it clear that during the academic year 2021-22, out of total 713 students, 93 students were from the Muslim minority community, 104 students were from the Sikh minority community and 516 students were Hindu. During the academic year 2022-23, out of total 898 students, 137 students were from the Muslim minority community, 122 students were from the Sikh minority community and 639 students were Hindu. It is relevant to mention here that during the academic year 2021-22 out of total 18 teachers 04 teachers are from Sikh minority community and 14 teachers are Hindu. During the academic year 2022-23, out of total 28 teachers, 06 teachers were from the Sikh minority community and 22 teachers were Hindu.

Whereas the information supplied by the petitioner with regard to students and teachers strength are different from the physical inspection report.
