An application has been received by hand on 11.9.2024 from St. Thomas English Medium School, Gejha Road, Mohiuddinpur, Meerut, Uttar Pradesh for grant of minority status certificate. It be registered.

2. It transpires from the petition that on 18.3.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Secondary Education Department, Government of Uttar Pradesh, Babu Bhawan, 7th Floor, Lucknow, Uttar Pradesh- 226 001, which was received by the respondent on 26.3.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. Petitioner has filed downloaded copy of letter dated 2.10.2022 issued by CBSE granting affiliation to the petitioner institution for the period 1.4.2023 to 31.3.2028.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Secondary).

6. The petitioner has not supplied complete details of students and teachers against Col. No. 6 (a)

7. It is mentioned against Col. No. 3 of the petition that the petitioner's application for grant of grant of Minority Status Certificate is pending before the State Authority.

8. So as per the law and settle procedure, petitioner cannot apply before this Commission until unless the disposal of that application which is still pending before the State Competent Authority. So this application is not maintainable at this stage.

9. Learned Counsel for the petitioner seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted.

10. The petition is disposed of as withdrawn. Office is directed to return additional sets, envelope and postage charges to the learned counsel for the petitioner. Record of Case No. 242 of 2024 be tagged with the record of this case.
