## **ORDER**

- 1. This petition has been received on 13.10.2023 by hand through Mr. Jose Abraham, Advocate of the petitioner institution for grant of Minority Status Certificate (in short 'MSC') to St. Theresa's School, Don Bosco Campus, Jay Prakash Ward-2, Betul District, Madhya Pradesh- 460 001.
- 2. Learned counsel for the petitioner filed an affidavit of Fr. Dominic Simon, Secretary of the Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd. and authorized representative of the applicant institution i.e. St. Theresa's School, Don Bosco Campus, Jay Prakash Ward-2, Betul District, Madhya Pradesh- 460 001 in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community. It is also stated in the affidavit that that the petitioner institution shall not deny admission of eligible candidate of the Christian minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution.
- 3. Learned counsel for the petitioner has filed notarized copy of Unique ID No.: MH/2017/0165208 of the petitioner's company as given by the Niti Aayog Portal NGO Darpan, copy of application dated 27.5.2023 sent to the State Competent Authority i.e. Secretary, Backward Classes and Minority Welfare Department, notarized copy of Certificate of

Registration dated 5.7.1965 of the Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd., Nagapur, notarized copy of Memorandum of Association and Articles of Association, amended Memorandum of Association dated 24.7.2012 of the said company, list of Governing Body Members for 2022-25, downloaded copy of order dated 1.11.2021 issued by the CBSE granting affiliation to the petitioner institution for the period 1.4.2022-31.3.2027 and resolution of the General Body of the Trust in favour of Fr. Dominic Simon, Secretary of The Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd. for obtaining MSC from this Commission.

- 4. As per the information supplied by the petitioner unaided institution with regard to students strength in academic year 2021-22, it is mentioned that out of total 685 students, 10 students were from the Christian minority community, 17 students were from the Muslim minority community, 4 students were from the Sikh minority community, 03 students were from the Jain minority community and 651 students were Hindus, in academic year 2022-23, it is mentioned that out of total 733 students, 16 students were from the Christian minority community, 19 student were from the Muslim minority community, 4 students were from the Sikh minority community, 03 students were from the Jain minority, 2 students were from the Buddhist minority community and 689 students were Hindu and in academic year 2023-24, it is mentioned that out of total 786 students, 17 students were from the Christian minority community, 39 students were from the Muslim minority community, 03 students were from the Sikh minority community, 03 students were from the Jain minority community, 04 students were from the Buddhist minority community and students were Hindu. It is relevant to mention here that in academic year 2021-22, out of total 32 teachers, 06 teachers were from the Christian minority community, 01 teacher was from Jain minority community and 25 teachers were Hindu. During the academic year 2022-23, out of 30 teachers, 06 teachers were from the Christian minority community and 23 teachers were Hindu and during the academic year 2023-24, out of total 30 teachers 06 teachers were from the Christian minority community, 01 teacher was from Jain minority community, 02 teachers were from the Buddhist minority community and 23 teachers were Hindu.
- 5. It is stated in the petition that on dated 27.5.2023, the petitioner institution has applied to the State Competent Authority for grant of NOC

which was received by the State Competent Authority on 29.5.2023 and the said application is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

- 6. Despite service of registered notice to the respondent dated 29.11.2023, the respondent has failed to apprise the Commission about the status of the said application. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 24.1.2024. After service of letter/email to the physical inspection committee dated 6.2.2024, District Collector, Betul has sent letter dated 2.4.2024 along with physical inspection report, which was received in the Commission's Office on dated 15.4.2024 wherein they have not recommended to grant MSC to the petitioner institution but not mentioned any adverse/negative comments. Population of Christian minority community in the State of Madhya Pradesh as per the census of 2011 is 0.29%. As per PIC Report, during the Academic Year 2021-22, out of 685 students, 10 students were from the Christian minority community which is 1.45% of the total students. During the academic year 2022-23, out of total 733 students, 16 students were from the Christian minority community, which is 2.18% and during the academic year 2023-24, out of total 786 students, 17 students were from the Christian minority community, which is 2.16%, which is more than the State census of 2011 i.e. 0.29%.
- 7. Heard learned counsel for the petitioner, perused the pleadings of the parties, the documents filed by the petitioner and affidavit of Fr. Dominic Simon, Secretary of the Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd. and authorized representative of the applicant institution i.e. St. Theresa's School, Don Bosco Campus, Jay Prakash Ward-2, Betul District, Madhya Pradesh- 460 001.

- 8. The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Christian minority community and is being administered by the Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd. which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Fr. Dominic Simon, Secretary of The Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd.
- 9. Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by the Commission in Case No. 1320 of 2009 dated 6.7.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Madhya Pradesh as per the census of 2011 is 0.29%.
- 10. I have perused the Amended Memorandum of Association of the petitioner Company which was registered before the Deputy Charity Commissioner, Nagpur Region on 24.7.2012 which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 27.5.2023 and petition for grant of MSC on dated 13.10.2023. So, it is clear that the amendment has been done before the application filed before the State Competent Authority U/s 10 of the NCMEI Act, 2004 and also petition for grant of MSC before this Commission.
- 11. The Amended Memorandum of Association dated 24.7.2012 and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said

facts also stand proved from the documents and affidavit filed by the

petitioner. There is no document on record to rebut the documentary

evidence produced on behalf of the petitioner institution.

12. Relying on the said unrebutted evidence produced on behalf of

the petitioner, we find and hold that St. Theresa's School, Don Bosco

Campus, Jay Prakash Ward-2, Betul District, Madhya Pradesh- 460 001

run by the Nagpur Roman Catholic Diocesan Corporation (Pvt.) Ltd. is

eligible for grant of minority status on religious basis. The evidence

also proves that the said educational institution was established with

the main objective of sub-serving the interests of the Christian minority

community.

13. Consequently, St. Theresa's School, Don Bosco Campus, Jay

Prakash Ward-2, Betul District, Madhya Pradesh- 460 001 is declared as

an unaided minority educational institution covered under Article 30 of

the Constitution of India within the meaning of Section 2(g) of the

National Commission for Minority Educational Institutions Act, 2004.

14. A minority status certificate be issued accordingly.

15. In view of the above, the present petition is disposed of in

accordance with this order.
