If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of msc will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.

An application has been filed by hand on 23.9.2024 from St. Anthonys Convent School, NUH Road, Karna, Palwal, Haryana- 121 102 for grant of minority status certificate. It be registered.

2. It transpires from the petition that on 29.2.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Principal Secretary, School Education Department, Room No. 37, 7th Floor, Haryana Civil Secretariat, Sector-1, Chandigarh- 160 001, which was received by the respondent on 2.3.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition.

3. The petitioner has filed copy of letter dated 29.4.2024 issued by CBSE granting affiliation to the petitioner institution for the period 1.4.2025 to 31.3.2030.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Secondary).

6. During the academic year 2022-23, out of 712 students, 15 students were from the Christian minority community, in the year 2023-24, out of total 673 students, 21 students and in the year 2023-24, out of 655 students, 23 students were from the Christian minority community.

7. It transpires that the amendment in the Memorandum of Association of the petitioner Society was done prior to filing application u/s 10 of NCMEI Act. 2004 before the State Competent Authority and also petition before this Commission for grant of Minority Status Certificate.

8. In the meeting convened by the Commission with the State Competent Authority of Haryana on 2.9.2024, the State competent authority has conveyed that they will issue separate guidelines for minority educational institutions for grant of No Objection Certificate.

9. Article 30 of the Constitution of India provides for linguistic and religious minorities a fundamental right to establish and administer educational institutions of their choice.
