Order dictated separately and pronounced, which reads as under: -

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the St. George English Medium School, Mannarkunnu, Sreekandamangalam P.O., Kottayam Dist., Kerala, run by the St. George Educational and Welfare Charitable Trust, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Christian minority community.

Consequently, St. George English Medium School, Mannarkunnu, Sreekandamangalam P.O., Kottayam Dist., Kerala, is declared as unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.

A minority status certificate be issued accordingly.

However, it is made clear that if the State Government has any objection in granting MSC in favour of the petitioner institution i.e. St. George English Medium School, Mannarkunnu, Sreekandamangalam P.O., Kottayam Dist., Kerala, the State is free to file an application for cancellation of MSC under Section 12(c) of the NCMEI Act, 2004.

In view of the above, the present petition is disposed of in accordance with this order.

Vide order dated 12.11.2024, the office was directed to return original documents to learned counsel for the petitioner but the said documents were not returned. Today the same is returned to learned counsel for the petitioner in court of the Commission.
