It transpires from the petition that on 19.8.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Higher Education, Room No. 3, Naveen Bhawan, UP Secretariat, Lucknow- 226 001, which was received by the respondent on 23.8.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.
- 3. The petitioner has filed notarized copy of letter dated 27.9.2022 issued by Secretary, Uttar Pradesh State Medical Faculty, Lucknow granting recognition to the petitioner institution for diploma in General Nursing and Midwifery Training for 40 seats per academic session.
- 4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.
- 5. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Education).
- 6. During the academic year 2023-24, out of total 40 students, 26 students were from the Jain minority community and in the year 2024-25, out of total 41 students, 23 students are from the Jain minority community.
- 7. It transpires from the petition that the amendment in the Trust Deed of the petitioner Trust was done prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.
- 8. Learned counsel for the petitioner is directed to file certified copies of all the relevant documents.
- 9. Office is directed to issue notice to the respondent by registered AD and e-mail.
