2. It is mentioned in the impugned order that the petitioner may file an appeal under Section 12(A) of the NCMEI Act, 2004. The Hon'ble Supreme Court in Civil Appeal No. 3945 of 2018 in case of Sisters of St. Joseph of Cluny vs. The State of West Bengal and Ors. vide order dated 18.04.2018, has held that any person who desires to establish a minority educational institution after the amendment Act of 2006 came into force, must apply only to the competent authority for grant of No Objection Certificate for the said purpose.

4. All applications for the establishment of a minority educational institution after the amendment Act of 2006 must go to the competent authority set up under the statute.

It transpires from the petition that on 19.8.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Assistant Director of Education (Act), Directorate of Education, Government of NCT of Delhi, R. No. 214-A, Old Secretariat, Delhi- 110 054, which was received by the respondent on 22.8.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized copy of order dated 12.6.2024 issued by the Municipal Corporation of Delhi, New Delhi granting recognition to the petitioner institution.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Primary).

6. During the academic year 2022-23, out of 475 students, all the students were from the Muslim minority community, in the year 2023-24, out of total 505 students, all students were from the Muslim minority community and in the year 2024-25, out of total 530 students, all the students were from the Muslim minority community.

7. It transpires from the petition that the Trust Deed of the petitioner trust was registered prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.

8. Clause 3.01 of the main objective of the Trust Deed only says "to establish and run schools and other such institution and institutions of higher learning" but it does not mention that the same is primarily for the benefit of the Muslim minority community and Clause 3.12 of the main objective of the Trust only speaks about promoting high standard of education and character building.

9. Heard learned counsel for the petitioner at some length.

10. List the case for further arguments on 22.1.2025.
