It transpires from the petition that on 8.7.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Principal Secretary, School Education Department, Government of Tamil Nadu, Rina Road, Fort St. George, Secretariat, Chennai, Tamil Nadu- 600 009, which was received by the respondent on 11.7.2024. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized copy of letter dated 13.6.2024 issued by District Education Officer, Directorate of Private Schools, Tamil Nadu granting renewal of recognition to the petitioner institution for the period from 1.6.2023 to 31.5.2026.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Primary).

6. During the academic year 2022-23, out of 247 students, 29 students were from the Christian minority community, in the year 2023-24, out of total 252 students, 30 students were from the Christian minority community and in the year 2024-25, out of total 237 students, 28 students were from the Christian minority community.

7. It transpires from the petition that the amendment in the Memorandum of Association of the petitioner society was done prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.
