This petition has been received on 06.12.2022 for grant of minority status certificate.

The petitioner has applied for grant of no objection certificate before the competent authority of the State Government on 27.08.2022, which was received by said authority on 30.08.2022 and the said application is still pending. The petitioner has waited sufficiently for a period of 90 days, before filing this petition.

The petitioner has already filed the proof of delivery of the registered AD to the respondent.

On 05.10.2023 a notice was issued by the Commission to the respondent. Despite service of notice, no reply received from the respondent.

Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 29.11.2023, after service of letter/ email to the physical inspection committee dated 03.01.2024, 04.01.2024, 04.03.2024, 07.06.2024, 05.09.2024 and 04.11.2024, District Collector and District Magistrate, Ariyalur, has sent a communication dated 21.10.2024, which was received in the Commission on 30.10.2024.

The District Collector and District Magistrate, Ariyalur vide his letter dated 21.10.2024 could not recommended for minority status certificate on the ground that petitioner has not applied through proper channel.

This Commission is functioning as per the NCMEI Act, 2004 read with the judicial pronouncements of the Apex Court for the purpose of declaration of MSC. Petitioner institution had applied for grant of NOC whereas the reply received from the respondent does not even murmured a single word with regard to the receipt and further process of the said application for NOC, which is duly received by the respondent.

Reply of the respondent does not hold much water as he has not mentioned about the aforesaid NOC application. Office is directed to issue notice to the District Collector & District Magistrate, Ariyalur and other members of the physical inspection committee, to apprise them about the Section 10 of the NCMEI Act and also direct him to inspect the petitioner institution and send the original physical inspection report duly signed by all the members of the physical inspection committee positively before the next date of hearing.

If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of MSC will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.
