4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is un-aided school (Higher Secondary).

6. The petitioner has not filed complete information against Col. No. 6(a) and also Resolution has not been signed by all the members of the society. The petitioner has not filed legible copy of MOA, Rules & Regulations etc.

7. Office is directed to issue notice to the petitioner to show cause as to why the petition should not be dismissed at this stage.
